Without identifying the source of the sinkhole, or making any repairs to the sewer line, can you let me know who authorized that they backfill the hole?

Was a soils engineer enlisted to inspect the hole, prior to it being filled? After it was filled? Also, please provide those corresponding reports.

Please forward what you have.

As an aside, we have asked the City for all records regarding that property previously, and nothing regarding the sink hole repair was provided.

Thanks. We look forward to seeing what you have.
